5. Approval of Minutes

The Board moved into closed session pursuant to Govt. Code Section 54957 to consider the Medical Advisor and or staff's recommendation regarding disability retirement applications.

The Board moved into open session.

7. Disability Retirements

It was **M/S/C** to accept the Medical Advisor's recommendation and grant the following disability benefits:

8. Gloria Alejandre

It was **M/S/C** to accept counsel's recommendation to grant Gloria Alejandre a service connected disability retirement. (Yes: Cabral, Gaynor, Hast, Holcombe, Pollacek, Telles, Viramontes)

9. Fox Lawson & Associates Report - Bruce Lawson

Lawson began by noting as requested by CCCERA, Fox Lawson & Associates has completed the compensation and benefits analysis of selected jobs within CCCERA using published salary surveys, including the recently completed 2008 CALAPRS Survey. The purpose of the analysis is to provide guidance regarding market competitive salary ranges for individual jobs.

He noted public and private data were analyzed along with compensation and supplemental benefits to achieve total compensation. He then reviewed the data sources used in the study, including the CALAPRS survey, Watson Wyatt data and a 2008 Mercer study.

Lawson discussed the targeted counties used in the study. The comparative job descriptions must have a minimum of a 70% job match. The study reviews job

descriptions in detail and chooses the jobs with significantly similar duties, noting it is impossible to get a 100% match.

He reviewed geographic adjustments, noting that not only are geographic markets are different across the nation; they also differ within specific labor markets. Geographic differential factors were collected by referencing the Economic Research Institute's Geographic Difference Reference Report. This geographic differential factor reflects wage and salary differentials by each geographic location. The different geographic locations and equivalents used for the study were discussed, including primary urban cities.

There was discussion on attracting high-end employees, applying the study to all CCCERA personnel, the different levels of employees involved, and the differences in structure of salary ranges for upper-level management as opposed to represented employees.

Board members discussed forming an ad-hoc committee with three Board members to discuss the study and return to the full Board with a recommendation. It was the consensus of the Board, since no action was included on this agenda, to agendize this item for action at a future Board Meeting

Board members commended Lawson and his firm for providing an excellent report.

10. SACRS Legislative Proposals

The three SACRS legislative proposals and one placer holder bill were discussed individually. It was **M/S/C** to support all three SACRS legislative proposals and the placer holder bill. (Yes: Gaynor, Hast, Holcombe, Pollacek, Telles, and Viramontes; Abs: Cabral)

Trustees discussed interest in obtaining the report for comparison purposes. Pollacek stated he will need the Kuhns report for bond rating.


Leedom noted she has information on the National Institute on Retirement, a new nation-wide organization. Discussion on membership for this organization will be included on the December agenda.
